## **Governor Signs JBAY Sponsored Bills**

### *State Takes First Step Toward Ending Mounting Homeless Youth Crisis*

Today, the Governor Jerry Brown signed two bills sponsored by John Burton Advocates for Youth: Senate Bill 918 (Wiener) and Senate Bill 1083 (Mitchell).

#### **Senate Bill 918: Homeless Youth Act of 2018**

Senate Bill 918 adds new responsibilities related to homeless youth to the Homeless Coordinating and Financing Council, the state entity charged with addressing homelessness in California. Of the four new responsibilities set forth in the legislation, key among them is setting specific, measurable goals to prevent and end homelessness among California's youth. Prior to passage of S 918, California was silent on the issue of youth homelessness, with no stated policy to address it.

According to Executive Director Amy Lemley, the state's announcement of an official goal to end youth homelessness is an important first step. "With this critical first step taken, California can start the hard work of ending youth homelessness by dedicating public resources, and ultimately, providing up a better, brighter future for the 1 in 10 youth who experience homelessness annually."

SB 918 is a compliment to investment in in the California State Budget, which set aside a minimum of five percent of the \$500 million Homeless Emergency Aid Program for unaccompanied youth under age 25.

#### **Senate Bill 1083: Extension of Deadline for Foster Families**

Senate Bill 1083 (Mitchell) extends the deadline for families who are converting from a foster care placement to a Resource Family by an additional year and clarifies that a parent and child welfare agency may agree to a Voluntary Placement Agreement.

This legislation was in response to extensive delays in the completion of the Resource Family Approval process, with many families waiting upwards of six months to be approved. Without this extension, families were at risk of losing financial support because they had not completed the Resource Family Approval, thereby putting children at risk of changing placements.
